1	<p>PROVIDING LAYING & FIXING KILN SEASONED CP TEAK WOOD SURFACE WOODEN FLOORING AS PER SPECIFICATIONS BELOW :</p> <p>a) SURFACE BOARD: - KILN SEASONED CP TEAK WOOD finished with 21mm thick, 57 to 83mm wide and in random length in tongue and groove shapes. The edges of the boards will have a finger lock groove and the bottom side with air pass groove and treated with special anti termite and water resistant lacquer.</p> <p>b) THE UNDER FRAME:- Made of commercial quality pine wood runners of 70 mm x 45 mm fixed with MS fastners, treated with anti-termite solution and fixed on the bottom side with 10 mm thick air cushioned EPDM Rubber pads, stapled through the two wings at 300 mm x 300 mm</p> <p>c) INSTALLATION: - IPS subfloor treated with a vapor barrier to be placed on the leveled IPS sub-floor before laying the under frame. The runners having air cushion pads to be placed on the vapor barrier in perfect level at 330 mm in 1 direction. The surface board to be screwed to the runner through the tongue only and will lock the screwed tongue by the groove of adjoining board. Ends of the boards will be locked by inserting the wooden fingers through the edge grooves and fixed with suitable adhesive. An expansion of 8 to 10 mm to be left open between the wooden flooring and the surrounding tiled area /walls.</p> <p>FINISHING: - After Installation the floor will be machine sanded with Level grinding machine, in uniform level and finished with imported non – skid DIN certified Polyurethane lacquer (Swedish Make) in 03 coats @ 1 ltr. Per 100 sqft. For each coating. Game Line Marking will be carried out in required colours before applying the finish coat.</p>	Sqm	550.5576
