**Even Semester 2022 Online Registration**

This is for information of UG/PG students that the following procedure be followed during the online even semester registration of B.Tech. 4<sup>th</sup>, 6<sup>th</sup> and 8<sup>th</sup> semester & PG 2<sup>nd</sup> & 4<sup>th</sup> semester, to be held from **11<sup>th</sup> to 13<sup>th</sup> January 2022**. Link for Online Registration will be available in the institute website. It may be noted that PG 2<sup>nd</sup> semester online registration will also be held during **11-13<sup>th</sup> Jan 2022** in lieu of **16-18- Jan 2022**.

- No clearance will be required for both UG and PG online registration.
- B. Tech. 4<sup>th</sup>, 6<sup>th</sup> and 8<sup>th</sup> semester students will be allowed to register for maximum 30 credits as per new regulation. However, under special circumstances, the students can register for one more course including lab course, exceeding the maximum credit limit with approval from Dean (Academic). Approval be sought by sending an e-mail to Dean Academic ([deanacd@nits.ac.in](mailto:deanacd@nits.ac.in))
- The credit limit for PG 2<sup>nd</sup> & 4<sup>th</sup> semester (M.Tech., M.Sc., MBA) will be as per norms.
- The fee for each backlog subject will be Rs.400.00 for respective semester.
- Students who want to avail Tuition Fee waiver have to produce the appropriate documents i.e. category certificate applicable for SC/ST/PwD candidates. Students whose annual family income is below 1 lakh or between 1-5 lakhs has to produce Annual Family Income Certificate issued by competent authority for the financial year 2020-21, issued on or after 01.04.2021. However, if a student fail to produce the document, he/she has to pay the tuition fee remitted in the last semester and can claim for refund (if any) after submission of the valid family income certificate issued on or after 01.04.2021.
- Students should complete Academic Registration within the scheduled period keeping payment processes pending in case they are unable to make the payment within 13<sup>th</sup> January 2022, they are allowed to make the payment within 31 January 2022.
- Students are to make payment of fees online on the said dates through SBI online portal i.e. [www.onlinesbi.com](http://www.onlinesbi.com). Semester-wise Institutional Fees are shown below:

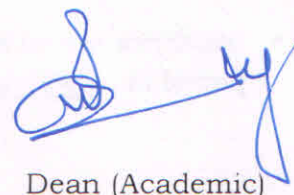
